



COUNTRY ASSIGNMENT LIST FOR HARVARD MODEL UNITED NATIONS 2011

The following table includes all the countries represented at HMUN 2011 in the General Assembly (GA), Economic and Social Council (EcoSoc), Regional Bodies (RB), and Specialized Agencies (SA). Every country is represented on the GA. A GA/RB/SA delegation must send at least seven delegates to the first six listed GA committees and the number of delegates listed in parentheses for each of the HGA and SA/RB as indicated on the dotsheet. Delegations on the Economic and Social Council must send six delegates to the committees listed as ES. Delegations with seats on the IOC and Peace of Westphalia will not be representing their countries, but rather will be representing a different entity to be assigned when delegation assignments are confirmed. This year no seats on application committees will be guaranteed, but assignments on special application committees will be given out earlier than in years past. Applications for special committees will be available in May and due on September 24.
